Parish Council - Thursday 18th March 2021 Agenda item 15 - Use of Zoom for Parish Council meetings

Purpose

The purpose of this paper is consider the implications of the withdrawal of the option for Parish Council meetings to be held remotely after May 7th 2021. A final decision about meetings in May and June will need to be taken at the April Parish Council meeting.

Legal Position

Parish Council meetings must be held in person. However, due to the CoVid-19 epidemic, various restrictions have been in place over the last 12 months, which would have prevented Parish Council meetings taking place in person. Legislation was introduced (via a Statutory Instrument) in 2020, to allow various meetings (including Parish Council meetings) to be held remotely.

This legislation expires on 7^{th} May 2021 and the UK government has indicated that it does not intend to extend it further. Unless this changes, with effect from 8^{th} May 2021, it would not be possible to have any further remote meetings and if held, they would have no legal standing.

National Association of Local Councils (NALC)

NALC continues to lobby the UK government to extend the option of holding remote meetings until at least 21st June (ie the current date when the "Roadmap" out of lockdown removes all restrictions on gatherings). NALC recommends that Councils continue to hold meetings online up to 7th May, but "prepare for the real possibility of a return to face-to-face meetings"

Based on current UK government advice about the roadmap out of lockdown, it is not expected that Village Halls would be available for Parish Council meetings before 17th May at the earliest. Even if village halls can re-open after this time there may be restrictions on numbers/social distancing, use of mask etc.

It is also recognised that some councillors may feel uncomfortable about meeting in person in May/June.

Contingency Plans

In the event that meetings cannot be held face-to-face and remote meetings are not allowed, the following contingency plans are suggested:

No other Committee meetings should be arranged for May/June until the legal position and availability of village halls is known. Essential business only can be added to full Council agenda if required (and subject to agreement of the Chairman).

This is a fluid situation and an update and proposal will be produced for the April Council to resolve the way forward.
